This is in reference to aforesaid Tender, following changes/additions/clarifications are incorporated in tender documents:

### 1. CHANGE OF EMPLOYER:

Demerger of LNG business of M/s Ratnagiri Gas & Power Pvt. Ltd. (RGPPL) into a separate company i.e. M/s Konkan LNG Pvt. Ltd. (KLPL) was approved by Board of Directors of RGPPL for long term viability of both power business & LNG business. The said demerger was approved by National Company Law Appellate Tribunal (Competent Authority) on 28.02.2018 under company appeal No. 294 of 2017. Subsequently, with filing of scheme with the Registrar of Companies, Delhi & Haryana, the effective date of LNG business of RGPPL (i.e. KLPL) stands as 26.03.2018.

Since Tender Enquiry Ref. No. RGPPL/C&M/CS-2589/OT-76 dated 19.01.2018 has been issued for the job of "Annual Maintenance Contract for Testing & Calibration of Pressure Safety Valves Installed at LNG" which pertains to LNG, hence as per aforesaid approval(s) instant job is assigned to M/s Konkan LNG Pvt. Limited (KLPL).
